Pass Heritage Park on left - L-O-N-G white fence, to the Yellow and Green train depot on the right. Turn right onto Salem Rd. \*Go to stop sign, about 100 yards, turn right. Go about 1/4 of a mile and bear left between churches on Salem Rd. Woods End Farm is 2 miles on the left. Arena is situated on Salem Rd.

**Directions from Athens:** Hwy 441 south through Watkinsville. Watch for Yellow/green train depot on left. Turn left on Salem Rd. and follow above directions\*.
